

Decree President of Islamic Republic of Afghanistan

In accordance to the Government of Islamic Republic of Afghanistan's commitment to bring reforms in the business climate and promote investment, as well as simplify business process, including moving of license issuance representatives to ACBR (one stop shop) the following decree is approved and be applicable to all ministries and other government independent bodies that are issuing licenses.

Article 1: Movement of license issuance representatives to ACBR (one stop shop)

- (1) As part of the initial stage for the establishment of ACBR, all ministries and other independent government bodies that are currently involved in issuing licenses are required to introduce at least one representative to Afghanistan Central Business Registry Unit (ACBR). The representatives should move to ACBR no later than one week after the issuance of this decree. The list of ministries is attached to this decree.
- (2) Ministries and independent government bodies other than those mentioned in annex #1 of this decree are excluded from the context of this decree.

Article 2: Policies & Procedures for ACBR (one stop shop)

(1) The Ministry of Commerce and Industries (MoCI) /ACBR is responsible to prepare a strategy to ensure that the ministerial and ACBR operations are integrated as soon as possible.
