ABOUT DAI

DAI is a company that was created in 1970. Since then. BACKGROUND

As a part of PROMOTE, DAI was awarded USAID-funded project Women in the Economy (WIE) in Afghanistan.

WIE program was implemented across five major provinces (Kabul, Herat, Mazar, Jalalabad, and Kandahar) in Afghanistan to increase women's participation in the formal economy and to advance their careers, by supporting businesses that were owned by women.

With the main focus on private sector development, WIE intended to help educated women with the skills and resources to enter and contribute to the workforce/ economy and provide support in the growth of businesses that are women-owned or have 10% or more women as their workforce in five major regional economic zones. One of the challenges defined as an obstacle in the development of the Micro, Small, and Medium Enterprises (MSMEs) is the lack of professional management skills and expertise. WIE wanted to demonstrate the value of trained professionals and recruit MBA graduates based on a cost-shared model with the private sector. WIE implemented the project's first session of the MBA Corps program in Kabul. DAI contacted Moore Afghanistan to deliver MBA Corps Program Management services to support project implementation. The assignment required high-level training for MBAs and host business monitoring and business action plan.

Meanwhile, the HR and payroll teams provided training on HR and payroll aspects of the business. The finance team provided them training on finance and QuickBooks software.
