## ABOUT FSSP

To ensure the effectiveness, efficiency, quality, and relevance of Canada's support in responding to Afghanistan's development challenges, the Afghanistan Development Program required access to local technical expertise, sector studies and strategies, monitoring along with supplementary administrative and logistical support. To meet these needs, Global Affairs Canada designed the Field Support Services Project (FSSP) to provide the required technical, organizational, and support services in Afghanistan.

## BACKGROUND

**After the fall of the Taliban in 2001, Canada has been actively involved in Afghanistan to help Afghans rebuild their country as a stable democratic and self-sufficient society.**

Canada's assistance mainly focuses on Humanitarian Assistance aligned with the Sustainable Development Goals and Afghanistan's National Priority Program.

Canada has committed \$3.3 billion in development assistance between 2001 and 2019 with a targeted focus on education, health (including maternal, newborn, and child health), human rights – particularly the rights and empowerment of women and girls – and humanitarian assistance including linking relief and recovery to development.

Afghanistan's Field Support Services Project (FSSP) facilitates delivery of a range of technical services, including technical analysis and advice in line with Canada's development priority themes, sectors, and initiatives, including results reporting, capturing lessons learned, and risk assessments; and support for emerging priorities.

## OUR ROLE
